## Personal data

He moved into the area of business continuity management in late 1997 and was made a Certified Business Continuity Professional (CBCP #4299) with the DRIL and certified as a CORM (in BCM & Audit) with The ICOR (#0502111M).

Prior to his current role in DRBCM Associates Pte. Ltd, he was the regional head of BCM with a major European bank with responsibility for the oversight of 17 countries in Asia Pacific and he held that post for 8-1/2 years until Mar 31, 2007.

Andrew is a very experienced instructor and a much sought-after conference speaker who is able to hold his audience and bring to life the subject matter at hand. In June 2009, he had been accredited as a Practising Management Consultant.
